04. Delivery should be given within 15 days from the date of receipt of order from this Vidyalaya. The items should be delivered in the Vidyalaya at free of cost.
05. A demand draft for **Rs. 2000/-** drawn in favor of “PRINCIPAL, JAWAHAR NAVODAYA VIDYALAYA, KOMMADI” on any scheduled bank payable at Visakhapatnam should be enclosed to the tender towards Earnest Money/Security Deposit.
06. The undersigned has every right to accept any one item or more items or all items from any individual tenderer (s). The undersigned is not bound to accept all items from a single tenderer.
