Last date for receipt of filled-in tender schedules is **25.05.2019, 4.30 P.M.** The tender schedules will be opened in the office of the undersigned at **11.00 A.M. on 27.05.2019**.

TERMS & CONDITIONS:

01. Tenders should be sent under strong sealed cover marked as “MEDICINES”.
02. The tenders shall be submitted according to the terms and conditions specified in paragraphs 3 to 12. Unless specified otherwise in the tender, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
03. There should not be any over-writing or corrections in the tender. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of the attested signature, the tender is liable to be rejected.
04. The undersigned does not bind himself to accept the lowest tender and reserves the right to accept the tender in whole or in part.
05. On acceptance of the tender it will become a contract and the contractor shall be bound by the terms and conditions of the tender.
06. A D.D. for **Rs. 1000/-** drawn on any Nationalized Bank payable at Visakhapatnam in favour of “The Principal, Jawahar Navodaya Vidyalaya, Kommadi” towards E.M.D should be enclosed to the tender and the same will be returned to the unsuccessful tenderers. The successful tenderer is required to pay a further sum of **Rs. 2,000/-** towards full amount of security of Rs. 3,000/- (Rs. 1000/- + 2000/-). The security deposit will be forfeited in the event of failure to comply with the contract.

If the contractor fails to supply the articles within the time stipulated, the undersigned shall be at liberty to purchase articles from the market or get the rest of the contract completed by any other person or firm and the difference of price, if any shall be deducted from the Earnest Money/Security Deposit and in case any amount in excess of the security deposit is paid by the undersigned, the contractor shall be liable to pay this amount.
08. The discount quoted by you shall hold good from **01-06-2019 to 30-04-2020**. No amendment in the rate will be accepted.
09. The Vidyalaya shall retain the amount of Security Deposit upto 30-04-2020.
