Terms & Conditions to the bidders for disposal of the material

All bidders/tenders should submit their sealed tenders along with a **Demand Draft of Rs. 2,000/- in favour of ‘Principal, Jawahar Navodaya Vidyalaya` Madhurawada as earnest money deposit (EMD)** which will be refundable to unsuccessful bidders. Tender should be supported with proof of identity (self attested copies of Ration Card/Voter ID etc.)
6. No tenders shall be accepted/entertained without earnest money deposit.

The highest bidder will be decided on the same day and he has to deposit the amount in form of draft payable to Principal, Jawahar Navodaya Vidyalaya, Kommadi, Visakhapatnam under next working day and after deposit the materials have to be removed within 3 days from the date of award letter/gate pass for removal of the material from JNV-Visakhapatnam.
12. The bidders should ensure that no damage is caused to the environment during storage & transportation of e-waste.
13. The person authorised by the highest bidders will be allowed to take delivery.
14. The Principal reserves the right to withdraw from the sale of any material from the lot at any stage without assigning any reasons thereof.
15. Since the disposal of the material is on "As is where is" basis the removal process should be in a very peaceful and smooth manner. No one shall be allowed to play any objectionable acts while removing the material from the premises of JNV.
